

External Trade – 2nd Quarter 2009

Introduction

This issue of the Economic and Social Indicators presents external trade statistics for the first and second quarters of 2009 and for the years 2007 and 2008. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

Thus while figures for 2008 published in this indicator are final, those for 2009 are subject to revision as and when the MRA - Customs Department submits latest amendments to the Central Statistics Office.

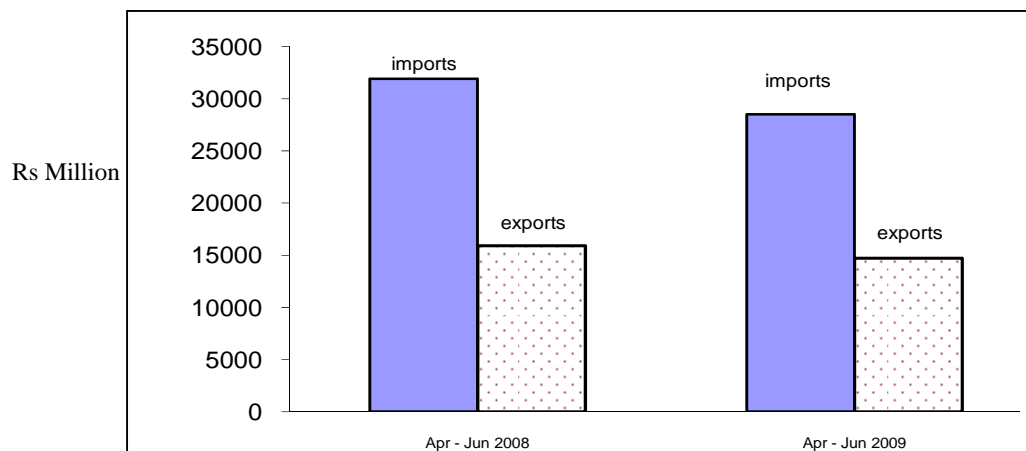
Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for. However, it was not possible prior to 2002 to include Freeport transactions in our general trade statistics because of different processing systems at the Customs Department and at the Mauritius Freeport Authority. Since mid-October 2001, transactions of the Freeport are being lodged through the Customs Management System (CMS), thus making it possible to integrate data of the Freeport zone with those of Customs.

Hence, as from 2002, data on imports and exports include transactions through the Mauritius Freeport. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius because it is not possible to distinguish between domestic exports and re-exports of freeport licensees. It is estimated that for the second quarter of 2009 some 38% of freeport exports were sourced locally.

1. Total value of trade and trade balance

Total international trade for the second quarter of 2009 was valued at Rs 43,212 million, i.e 9.0% higher than the previous quarter but 9.6% lower than the corresponding quarter of 2008.

During the second quarter of 2009, total exports were valued at Rs 14,714 million against imports of Rs 28,498 million. This resulted in a trade deficit of Rs 13,784 million, compared to deficits of Rs 11,130 million (+23.8%) for the previous quarter and Rs 16,027 million (-14%) for the corresponding quarter of 2008.



Based on data for the first semester of 2009 and past trends, total exports for the year 2009 are expected to be of the order of Rs 64,000 million, against Rs 114,000 million for imports. The trade deficit would be around Rs 50,000 million.

2. Exports

2.1 Total exports (Table 1)

Total export proceeds for the second quarter of 2009, including domestic exports¹, re-exports² and ships' stores and bunkers, amounted to Rs 14,714 million, showing an increase of 3.2% over the previous quarter but a decrease of 7.5% compared to the corresponding quarter of 2008.

Domestic exports, which accounted for 75.3% of total exports, went up by 2.2% from Rs 10,735 million in the previous quarter to Rs 10,976 million in the second quarter of 2009. Compared to the corresponding quarter of 2008, domestic exports were higher by 5.7%. For the second quarter of 2009 re-exports stood at Rs 2,574 million, i.e higher by 13.3% compared to the previous quarter. However, compared to the corresponding quarter of 2008 the figures were lower by 14.6%.

Total exports for the first semester of 2009 was Rs 28,976 million, showing a decrease of 3.6% over the first semester of 2008.

2.2 Exports by SITC section - (First semester 2009)

Exports of "Food and live animals" for the first semester of 2009 amounted to Rs 8,197 million showing an increase of 20.7% over the first semester of 2008. Exports of sugar and "fish and fish preparations", the major components of this section, went up by 9.1% and 29.7% respectively (Table 3).

For the first semester of 2009, exports of "Manufactured goods classified chiefly by material" were valued at Rs 2,536 million, lower by 0.3% compared to exports for the first six months of 2008, valued at Rs 2,544 million.

Total exports of "Machinery and transport equipment" for the first semester of 2009 dropped by 67.4% compared to the corresponding semester of 2008 as a result of a substantial fall in re-exports of mobile phones to the United Arab Emirates (UAE).

Export proceeds from "Miscellaneous manufactured articles", contributing 52.0% of total exports from January to June 2009, increased by 0.3% compared to the first semester of 2008 to reach Rs 13,803 million. Exports of "Articles of apparel & clothing accessories" representing 86.5% of exports of this section showed an increase of 2.2%.

2.3 Exports of Export Oriented Enterprises(EOE) - (First semester 2009)

During the first semester of 2009 exports of the EOE amounted to Rs 17,567 million showing an increase of 4.6% compared to the corresponding period of 2008 (Table 1). Details on exports of these enterprises will be presented in the Economic and Social Indicators on the Export Oriented Enterprises, which will be released on 21 September 2009.

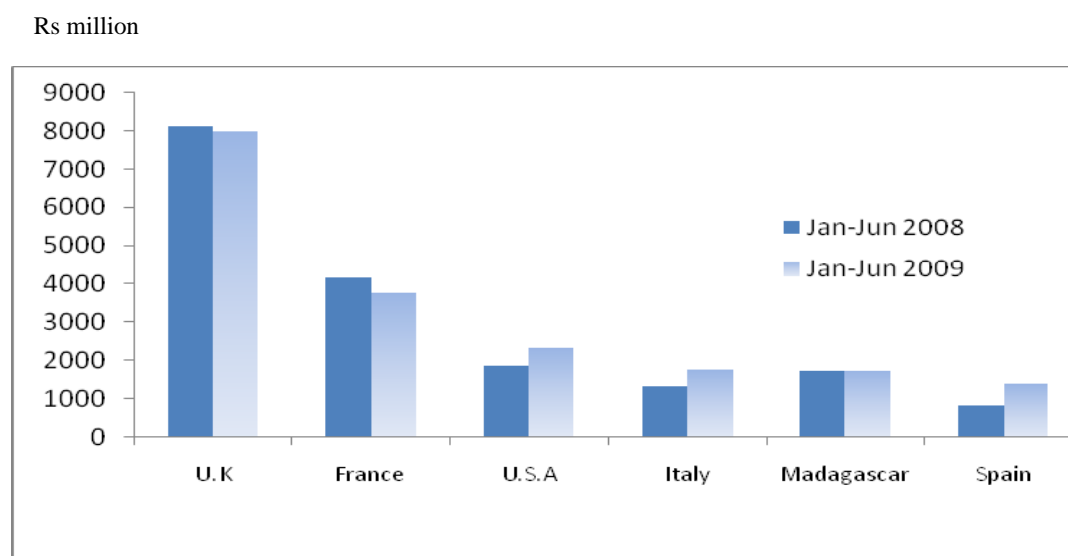
² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

2.4 Exports by Country of destination - (First semester 2009)

Analysis by country of destination for the first semester of 2009 shows that the European countries purchased some 67.4% of our exports for an amount of Rs 17,898 million. The United Kingdom remained our main market with Rs 7,976 million, or 30.0% of total exports. The other major destinations for our exports were France (14.2%), U.S.A (8.7%), Italy (6.6%), Madagascar (6.5%) and Spain(5.2%) - (Table 7).

Compared to the first six months of 2008, total exports to France, UK and Madagascar went down by 10.0%, 1.8% and 0.7% respectively. However exports to Spain, Italy and U.S.A rose by 60.5%, 33.2% and 24.1% respectively. A significant drop of 85.0% was recorded in total exports to the United Arab Emirates as a consequence of the decrease in re-exports of cellular phones to that country. Further details are given in Table 6.

3. Imports

3.1 Total imports - (Table 1)

Total imports for the second quarter of 2009 reached Rs 28,498 million, showing an increase of 12.2% over the previous quarter but a decrease of 10.7% over the corresponding quarter of 2008.

Total imports for the first semester of 2009 amounted to Rs 53,890 million, showing a decrease of 14.1% over the corresponding semester of 2008.

3.2 Imports by SITC section - (First semester 2009)

Imports of “*Food and live animals*” for the first semester of 2009 were valued at Rs 10,902 million, i.e 8.5% lower than those of the corresponding period of last year. The most significant decreases were noted in imports of rice (-22.6%), dairy products (-21.8%) and fish and fish preparations (-21.8%). On the other hand imports of wheat increased by 76.9% (Table 10).

The import bill of “*Mineral fuels, lubricants, & related products*” stood at Rs 8,324 million representing a fall of 44.3% over the corresponding semester of last year.

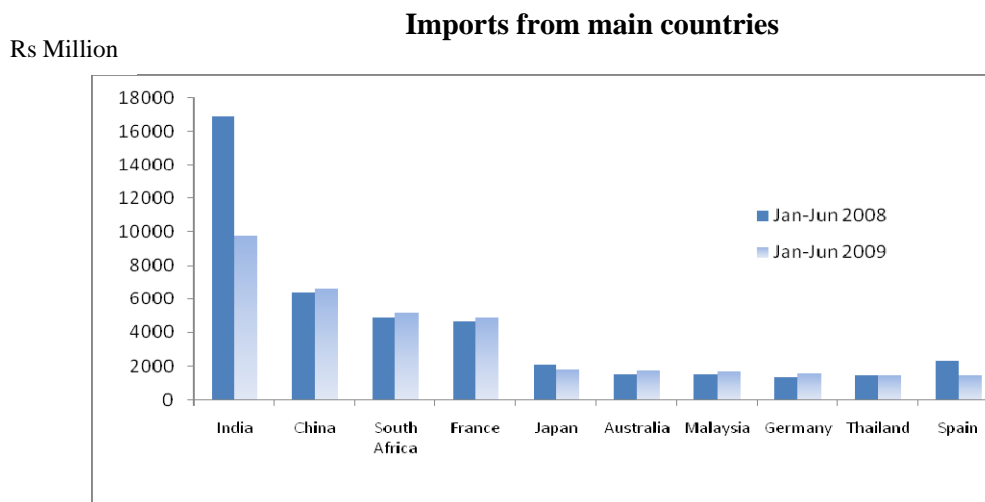
Imports of “*Manufactured goods classified chiefly by material*” for the first semester declined by 11.2% to reach Rs 10,155 million. The main decreases being in “cement” (-31.9%) and “textile yarn”(-23.1%) ,

For the first semester of 2009, imports of “*Machinery & transport equipment*” which were valued at Rs 11,863 million went up by 5.5%, the most important increase being in “general industrial machinery & equipment & machine parts” (+68.8%).

3.3 Imports by country of origin – (First semester 2009)

During the first semester of 2009, imports from the Asian continent, our major supplier, amounted to Rs 26,199 million with a share of 48.6% of total imports.

Our imports originated mainly from the following countries: India (18.1%), China (12.3%), South Africa (9.5%), France (9.1%), Japan (3.3%), Australia (3.2%),Malaysia (3.1%) Germany (2.9%), Thailand (2.7%) and Spain (2.7%). The high share of India in our import bill is explained by the fact that India is our main supplier of petroleum products since the last quarter of 2008 (Table 13).



4. Trade with Regional Organisations – (First semester 2009)

Total exports to African, Carribean and Pacific (ACP) States during the first semester of 2009 stood at Rs 3,782 million, against imports of Rs 7,018 million (Table 14). The trade deficit with ACP countries worked out to Rs 3,236 million.

During the first semester of 2009, our exports to COMESA countries attained Rs 2,375 million while imports from these countries amounted to Rs 1,696 million resulting in a favourable trade balance of Rs 679 million for Mauritius. Madagascar was the main buyer with a share of 72.6%. The main products exported to Madagascar were yarn of carded wool and preparations used in animal feed. Our main suppliers were Kenya (42.7%), Egypt (19.7%) and Madagascar (16.9%). The main products imported from Kenya were cigarettes containing tobacco while other preparations for cleaning or disinfecting (excluding detergents) constituted

the main products imported from Egypt. Our imports from Madagascar consisted mainly of liquefied butanes and coniferous wood sawn. (Table 15).

Trade with SADC countries for the first semester of 2009 showed a deficit of Rs 2,857 million, resulting from imports of a value of Rs 5,896 million and exports worth Rs 3,039 million. The main supplier was South Africa (87.1%) and our main buyers were Madagascar (56.7%) and South Africa (40.3%). It can be noted that imports from Mozambique increased significantly in the first semester of 2009 on account of imports of cotton (Table 16).

5. Trade in Freeport Zone - (First semester 2009)

During the first semester of 2009, total imports of the Freeport Zone stood at Rs 2,550 million, a figure which is higher by 7.5% compared to the corresponding period of last year. The main items imported through the Freeport were “Fish and fish preparations” “Chemicals and related products & accessories etc.” and “Textile yarns, fabrics, and made up articles” (Table 12).

Re-exports to overseas markets were valued at Rs 3,370 million, showing a decrease of 16.1% when compared to the first semester of 2008. The main items re-exported by the Freeport were “Fish and fish preparations” and “Articles of apparel and clothing accessories” (Table 6). Items falling under “Articles of apparel and clothing accessories” were sourced mainly from Export Oriented Enterprises.

It is worth noting that the decrease in re-exports by the Freeport is attributed to a significant decrease in exports of mobile phones.

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2007). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
