Both envelopes should indicate the closing date and should be addressed to the Chairman, Central Procurement Board and should be deposited in the Tender Box Office or sent by Registered Mail so as to reach the Chairman, Central Procurement Board at the under-mentioned address on Thursday 16<sup>th</sup> July 2009 up to 13.30 hours (local time) at latest.
