4. Licensed agents are reminded that they should display the following information in their office.

- (i) The licence bearing the names of the educational institutions for which the institution is authorized to operate,
- (ii) The quality and cost of the courses offered;
- (iii) Reasonable monthly living costs of a student;
- (iv) The quality and cost of health facilities available to a student;
- (v) The level of security at the institution.

5. Further it is an infringement of the law for any person to proceed with the recruitment of students for institutions for which a licence has not been granted.
6. The attention of the public is drawn to the fact that no person should act as an agent, unless he/she holds a licence to that effect. In addition, members of the public who have been aggrieved by “Recruiting Agents” are advised to report the matter to the Ministry or to the Police so that necessary action may be initiated against them.
