The forms duly filled-in, together with photocopies of relevant documents, signed, placed in a sealed-envelope marked "Registration of Suppliers" on the top right-hand corner, and addressed to the Manager Procurement and Supply, must be deposited in the registry, Ministry of Education, Culture & Human Resources, Central Supplies Division, St Vincent Road, Vacoas by 10.30 hours at latest (local time) on 30 June 2009.

Applicants are invited to take note of the following:-

- (i) procurement of goods, works and services will be governed by the Public Procurement Act (2006)
- (ii) price of items offered need not be submitted at this stage;
- (iii) the Ministry of Education, Culture & Human Resources has no contractual obligations towards any potential applicant whomsoever;
- (iv) this exercise shall not entitle applicants to become exclusive suppliers of the Ministry of Education, Culture & Human Resources; and
- (v) the Ministry of Education, Culture & Human Resources reserves the right to proceed with tender procedures at any time regardless of the outcome of this registration exercise.
