## **II. RESEARCH, LEGISLATION AND LABOUR STANDARDS SECTION**

### **1. LEGISLATION UNIT**

#### ***New Remuneration Regulations made –***

- The Remuneration Orders (Amendment) Regulations to include the Additional Remuneration for 2010 were made on 2 April 2010 and became effective as from 1 January 2010.
- The Sugar Industry (Agricultural Workers) (Amendment) Regulations and the Sugar Industry (Non-Agricultural Workers) (Amendment) Regulations to provide for the 40-hour week during crop season were made on 2 April 2010 and became effective as from 10 April 2010.
- The Attorneys' and Notaries' Employees (Remuneration Order) Regulations were repealed and replaced by a new Regulations with effect from 1 September 2010. The new Regulations which cover some 800 workers, have granted a wage increase varying from 9 to 12% to the different categories of workers and improved several of their conditions of employment.
- The Domestic Workers (Remuneration Order) Regulations were repealed and replaced by a new Regulations with effect from 1 December 2010. The new Regulations which cover some 43,000 households employing domestic workers, have granted a wage increase varying from 10 to 22% to the different categories of workers and improved several of their conditions of employment.

## **2. LABOUR STANDARDS UNIT**

### ***(i) Elaboration of a Decent Work Country Programme (DWCP) for Mauritius***

The project on the elaboration of a Decent Work Country Programme for Mauritius, launched in November 2008, aims primarily at promoting decent employment through specific programmes and activities, determined in consultation with social partners. The DWCP document has been finalized by Mrs. E. Hanoomanjee, national consultant appointed by the ILO, on 25 November 2010 after intensive consultations with tripartite constituents.

Before reference to Cabinet for approval, the document has been forwarded to the different Ministries concerned for approval of their respective programmes/activities and estimated budget and to the Ministry of Finance and Economic Development for clearance with respect to its budgetary implications. The final step in the DWCP elaboration process will be the signing of the document by tripartite constituents i.e. Government, workers' and employers' organizations.

### ***(ii) Elimination of all Forms of Discrimination in the Existing National Mauritian Law – “Harmonisation Study”***

Following a study on the Elimination of all Forms of Discrimination in the Existing National Mauritian Law, carried out under the UNDP Project “Capacity Building for Gender Equality and Empowerment of Women”, a Monitoring Committee, co-chaired by the Minister of Labour, Industrial Relations & Employment and the Attorney-General, has been set up in February 2010 with a view to implementing the report of the study.

Stakeholders including concerned Ministries, the private sector, workers' organizations and NGOs, have been invited to submit their views on the report and their inputs will be considered by the Monitoring Committee in conjunction with the recommendations contained in the report in the implementation phase.
