

**Local Government Service Commission Circular Note No. 61 of 2011**

**Vacancies for the Post of Driver (Roster)**

**Grand Port/Savanne District Council**

Applications are invited from among serving employees of the Grand Port/Savanne District Council who wish to be considered for appointment as Driver (Roster) in that District Council.

The permanent and pensionable post carries salary in the scale of Rs. 8 800 x 200 - 10 200 x 250 - 11 700 x 300 - 13 200 a month plus salary compensation at approved rates.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 8 800 a month plus salary compensation at approved rates.

**2. Qualifications :**

By selection from among employees holding a Goods Vehicle Licence and who possess the Certificate of Primary Education or can show proof of being literate.

Note:

Candidates should enclose photocopies of their Driving licence, National Identity Card, academic/technical qualifications and where applicable, relevant documentary evidence of experience claimed.

**3. Duties :**

1. To drive and operate Refuse Collection lorries and other vehicles involved in refuse collection as well as any other vehicle of the Council.
2. To carry out simple maintenance tasks including: -
  - (a) regular washing and cleaning of cabin (Exterior and interior) and chassis; and
  - (b) regular checking of radiator and filling up with water if necessary;
  - (c) regular checking of engine oil pump and topping up if necessary;
  - (d) regular checking brake clutch and master cylinders and topping up if necessary;
  - (e) regular checking wheel nuts for wheel tightness; and
  - (f) effect other checks for the good running of the vehicles.

3. To report any defect immediately to the Responsible Officer.
4. To effect minor repairs to the vehicle under his responsibility, including changing of punctures tyres with the assistance of Refuse Collectors.
5. To help, whenever required, the Mechanics when the vehicle or engine is under repairs.
6. To keep proper record of fuel, oil and mileage performed and any other relevant records in a logbook.
7. To perform other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

**Note 1: Drivers (Roster) should abide by the provisions of the Financial Management Manual concerning responsibilities of a Driver of his vehicle.**

**Note 2: Drivers (Roster) are expected to work on a roster basis or at staggered hours without extra remuneration.**

- (ii) Candidates should submit their applications in duplicate, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission **within a week after the closing date**.
- (iii) Candidates are advised to read carefully the 'NOTES AND INSTRUCTIONS TO CANDIDATES' before filling in the application form.
