Vacancies for the Post of Tradesman (Painter)
Grand Port/Savanne District Council

Applications are invited from qualified persons residing within the boundaries of the Grand Port/Savanne District Council who wish to be considered for appointment as Tradesman (Painter) in that District Council.

The permanent and pensionable post carries salary in the scale of Rs 8,800 x 200 - 10,200 x 250 - 11,700 x 300 - 13,800 x 400 - 15,000 a month plus salary compensation at approved rates.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 8,800 a month plus salary compensation at approved rates

II. QUALIFICATIONS:

Candidates should reckon at least two years' experience in painting and hold:-

Either: (i) the Certificate of Primary Education

(ii) the National Trade Certificate level 3 awarded by the IVTB in painting

OR

(iii) the trade test certificate in painting

OR

(iv) an alternative qualification to (i), (ii) & (iii) above acceptable to the Local Government Service Commission.

Note 1: Candidates should show proof of all experience claimed.

Note2: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications and where applicable, relevant documentary evidence of experience claimed.

III. AGE LIMIT

Candidates should have reached their 18th birthday and unless already in the Local Government Service/Public Service/Approved Service should not have reached their 48th birthday by the closing date for the submission of applications.

IV. DUTIES:

1. To carry out the necessary measurements and calculations of the trade.
2. To use and keep in good condition the tools in general use in the trade.
3. To remove all paint with soda solution, wash and burn off paint.
4. To prepare surfaces for painting.
5. To make a putty.
6. To sand paper, paint (brush), stop up, flat down with pumice and varnish (brush) and apply putty, paints and varnishes.
7. To do ordinary distempering including preparation of walls if required.
8. To do simple glazing.
9. Must be able to prepare, mix and match paints and to use linseed oil, boiled and raw.
10. To ensure good safety conditions while on duty.
11. To perform other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

- (ii) Candidates already in the Local Government Service should submit their applications in duplicate, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission within a week after the closing date
