

Local Government Service Commission
Vacancy for the post of Tradesman (Painter)
Moka/Flacq District Council

Applications are invited from qualified persons residing within the boundaries of the Moka/Flacq District Council who wish to be considered for appointment as Tradesman (Painter) in the said Council.

The permanent and pensionable post carries salary in the scale of Rs 8,800x 200 – 10200x 250 – 11700 x 300 – 13800 x 400 – 15000 a month plus salary compensation at approved rates.

Appointment in a temporary capacity carries salary at the flat rate of Rs 8,800 a month plus salary compensation at approved rates.

2. **Qualifications :**

By selection from candidates reckoning at least two years' experience in the trade and who hold: -

Either (i) the Certificate of Primary Education;

(ii) the National Trade Certificate level 3 awarded by the IVTB in painting.

Or

(iii) the trade test certificate in painting;

Or

(iv) an alternative qualification to (i), (ii) & (iii) above acceptable to the Local Government Service Commission

Note: Candidates should enclose photocopies of their National Identity Card, academic/professional qualifications and, where applicable, relevant documentary evidence of experience claimed

3. **Age Limit**

Candidates should have reached their 18th birthday and, unless already in the Local Government Service/Government Service/Approved Service should not have reached their 45th birthday by the closing date for the submission of applications.

4. Duties :

1. To carry out the necessary measurements and calculations of the trade;
2. To use and keep in good condition the tools in general use in the trade;
3. To remove all paint with soda solution, wash and burn off paint;
4. To prepare surfaces for painting;
5. To make a putty;
6. To sand paper, paint (brush), stop up, flat down with pumice and varnish (brush) and apply putty, paints and varnishes;
7. To do ordinary distempering including preparation of walls if required;
8. To do simple glazing;
9. Must be able to prepare, mix and match paints and to use linseed oil, boiled and raw;
10. To ensure good safety conditions while on duty; and
11. To perform other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings

5. Mode of Application

- (ii) Candidates already in the Local Government Service should submit their applications in duplicate, the original should be sent directly to the **Secretary** of the Local Government Service Commission and the duplicate one to their Responsible Officer, who will forward it to the Commission within a week after the closing date.

- (iv) The envelope should be clearly marked on the top left-hand corner :-
