## INVITATION FOR EXPRESSION OF INTEREST FOR

### Registration of Suppliers for Year 2012 – 2014 (MPS/EOI/RS/2012)

1. The **Mauritius Prisons Service** invites Expression of Interest from Potential Suppliers/Contractors for items listed below. Future bidding processes shall be conducted through Bidding Procedures according to the Public Procurement Act 2006 in the following fields:

#### **Goods, Services, Works and Consultancy Services**

- Dry provision & Spices, Fresh Vegetables, Flour, Ration Rice, Refined Sugar, Bakery products & Equipments, Frozen Meat, Frozen Fish, Frozen Chicken, Eggs, Cleaning Materials, Petty Store Items, Building & Construction Materials (Cement, Rocksand, Macadam, Iron Bars), Waterproofing Work & Products, Electrical Items, Plumbing Items, Shoe & Shoe Products, Disciplinary Uniform Products, Stitching of Uniform Items (Shirt, Pants, Suit etc.), Bedding & Clothing Items, Heavy Duty equipment & Gardening tools, Industrial Cleaning Equipments, Office furniture, Electrical Appliances, Office Equipments, Cleaning & Sanitact Services, Consultancy services for CCTV, Security Implements & Equipments, Protective Equipments, Pharmaceutical Products (Including Animals), Personal Computer & Printer, Heavy Duty Kitchen Equipments & Utensils, Air-Conditioner & Maintenance Services, Refrigeration Services, Servicing & Repair of Kitchen Equipments, Installation of Gas Pipe & Servicing, Stationery Products, Genuine Toners & Cartridge, Animal Feeds, Vehicle Spare parts, New Vehicles (Cars, Lorry, 2x4, 4x4, Box Van etc.), Fibre Water & Sceptic Tanks, Cigarette (of Lowest Price), Mobile Phone & Repairs, Telecommunication Cabling Work & Supply of Equipments, Solar Water Heater, Generators & Maintenance), Pesticides & Insecticides, Security Dogs, Cell Locks, Tiles & Sanitary wares, Rental of Trucks .

Expression of Interest together with your curriculum vitae and **Suppliers Registration Form** in sealed envelope clearly marked **Expression of Interest for Registration of Suppliers** must be addressed to the **Office of the Commissioner of Prisons** and deposited in the Tender Box at the **Mauritius Prisons Service, Prison Headquarters, Central Prison, Beau-Bassin** on or before **Wednesday 7<sup>th</sup> December 2011 by 13.00 hrs (Local Time)** at latest. Electronic bidding **shall not** be permitted. Late bids will be rejected.
  5. All applications must be made on the Supplier Registration Form which is obtainable from either calling at the address at **para. 4** or by downloading from **<http://www.gov.mu/portal/site/prisons>**.
  6. The address for submission of Expression of Interest is as referred in **para. 4**:
